Shall the Charter Township of Clayton levy up to 2.9 mills against the taxable property within the Charter Township of Clayton commencing on December 1, 2021, for a period of 5 years raising up to an estimated \$662,569 in the first year the millage is levied? The purpose of this levy is to provide funding for the operation of the Charter Township of Clayton Police Department.

This millage replaces the 1.9 mills millage that expired in 2020 and the 1.0 mills millage that expires in 2021 for a total of up to 2.9 mills for the operation of the Clayton Township Police Department.
